- SELLER AGREES TO PROVIDE QUALITY VET CARE FOR THE PUPPY WHILE IN SELLERS CARE.
- SELLER AGREES TO PROVIDE AND HONOR A 24 MONTH FROM TIME OF WHELPING HEALTH GUARANTEE OUTLINED IN THE HEALTH GUARANTEE.
- SELLER WILL PROVIDE VET RECORDS AND INFORMATION REGARDING THE HEALTH AND CARE DURING WHICH THE SELLER WAS IN CARE OF THE LABRADOODLE.
- SELLER WILL PROVIDE A COLLAR, COMPLETE PUPPY PACK WITH VARIOUS PUPPY INFORMATION, INSTRUCTIONS AND FOOD FOR YOUR PUPPY AT TIME OF PICKUP.

- SELLER WILL ALWAYS BE AVAILABLE TO ASSIST AND HELP WITH ANY QUESTIONS BUYERS MAY HAVE AFTER SALE REGARDING THE PUPPY.
- SELLER AGREES TO MICRO-CHIP ALL PUPPIES PRIOR TO PICKUP.
- SELLER AGREES TO HAVE PUPPY VET EXAMINED AT LEAST ONCE AND GIVEN WORMING MEDICINE AT 6 AND 8 WEEKS OF AGE.
- VACCINATIONS WHILE IN THEIR CARE AT SELLERS EXPENSE.
- SELLER AGREES TO FEED A VERY HIGH-QUALITY PUPPY FOOD WHILE IN THE CARE OF THE BREEDER.
- BUYER UNDERSTANDS THAT UNLESS THE SIRE AND DAM HAVE ALREADY BRED PRIOR TO DATE OF THIS CONTRACT, THAT THE ESTIMATED DUE DATES, WHELPING DATES, AND PICKUP DATES ARE ESTIMATED DATES ONLY AND COULD CHANGE. IF BREEDING SHOULD NOT RESULT IN PREGNANCY SELLERS WILL INFORM BUYERS OF CHANGES AND BUYERS AGREE TO A REFUND OF DEPOSIT OR MOVE TO NEXT AVAILABLE LITTER.
- BUYER AGREES TO HOUSE THIS LABRADOODLE INSIDE THEIR HOME OR PROPER/SANITARY KENNEL PROTECTED FROM EXTREME CONDITIONS AND FURTHER AGREES THAT THEIR LABRADOODLE WILL NOT BE CHAINED OR TIED UP WHILE LEFT UNATTENDED.
- THE BUYERS UNDERSTAND THAT THEY ARE REQUIRED TO PROVIDE: REGULAR VETERINARIAN CARE, RECOMMENDED AND REQUIRED VACCINATIONS, RABIES SHOTS, KEEP PUPPY FREE OF PARASITES, PROVIDE REASONABLE CARE. ANY EVIDENCE OF ABUSE, INJURY, ACCIDENT, OR POOR OR LACK OF CARE, MALNUTRITION OR BREEDING THIS DOG (UNLESS ALLOWED BY THIS AGREEMENT) **WILL VOID THE HEALTH AGREEMENT.**
- BUYERS UNDERSTAND THAT THE SELLERS CANNOT GUARANTEE THE FINAL COLOR OR COAT TYPE OF THE LABRADOODLE AS AN ADULT. THE COLOR OF THE LABRADOODLES COAT CAN LIGHTEN OR CHANGE AS THEY MATURE. MOST PUPPIES COATS REMAIN VERY CLOSE TO THE SAME COLOR AS THAT OF TIME OF ADOPTION HOWEVER, LABRADOODLES COATS SOMETIMES GET LIGHTER OR ACQUIRE HIGHLIGHTS IN THEIR COATS. BLACKS CAN CHANGE TO GREY OCCASSIONALLY, CHOCOLATES CAN CHANGE TO MOCHA ETC.

- THE BUYER UNDERSTANDS THAT PRIOR TO, DURING AND AFTER THE BIRTH OF PUPPIES, THAT THERE CAN BE MEDICAL COMPLICATIONS JUST LIKE WITH HUMAN BIRTHS. THE SELLER DOES EVERYTHING POSSIBLE TO INSURE THE HEALTH OF THE BREEDING PARENTS AND ALL PUPPIES AT ALL TIMES. THE BUYERS UNDERSTAND THAT IF FOR ANY REASON THE NUMBER OF PUPPIES EXPECTED OR RESERVED BY BUYER ARE LESS THAN LITTER CONTAINS, THE BUYER MAY MOVE TO THE NEXT LITTER OR DEPOSIT REFUNDED AS DESIRED BY THE BUYER.
- BUYER AGREES TO HAVE THE ABOVE MENTIONED LABRADOODLE SPAYED/NEUTERED ***BEFORE 8 MONTHS OF AGE*** UNLESS NOTED. IF THE BUYER DOES NOT SPAY/NEUTER THIS PUPPY, THE BUYER AGREES TO PAY THE SELLER \$5000.00 UPON DEMAND AFTER 8 MONTHS. BUYER AGREES TO PROVIDE SELLER PROOF OF SPAY/NEUTERING. \*\*\*\*
